
Special Free Event To Look Back on A.A. History

Lots to Discuss Before the April 22–28 A.A. GSC

Most of us won't attend the April 22–28 68th General Service Conference of Alcoholics Anonymous in New York. But our voices can be heard there!

Between now and April 7, the General Service Representative (GSR) or Alternate GSR in every A.A. meeting should share the agenda items that will be discussed at the GSC. The GSRs should then bring any feedback or questions from their group to the Area 20 Pre General Service Conference Workshop (PGSCW) which will take place on April 7 at Lord of Life Lutheran Church, 40W605 IL Route 38, Elburn, IL.

The purpose of the PGSCW is to prepare Robert S., our Area 20 Delegate, to represent

Area 20 at the GSC. This is where the groups' conscience is heard at the Area level and carried through to the GSC in New York through Robert.

District 10 Secretary Steve B. has forwarded the GSC agenda items and background to our GSRs. GSRs should contact Steve if they did not receive the agenda documents.

Robert S. will be invited to report on his visit to the GSC at a future District 10 meeting. Because the agenda contains nearly 80 items divided into 13 sections, GSRs are encouraged to pick out any that may be of particular interest or concern to their group.

When My Sponsor Died—An Unexpected Part of My Sobriety

If I continue to work my A.A. program, attend A.A. meetings and keep the plug in the jug, on March 24, I will mark 33 years of sobriety. During that time, I have dealt with pain, loss, fear and confusion. For me, the toughest test of my program was when my sponsor, Don C., died.

Don technically was my second sponsor. Dick S. was the man who returned my call to the Chicago Answering Service on a Sunday evening and asked me if I wanted to attend an A.A. meeting the next day. Dick brought me to the Alano Club of Northside Chicago, 5555 N. Lincoln Ave., where I began my recovery.

While Dick helped me to get a solid foundation in the program, and guided me through my Fourth and Fifth Steps, as I approached my second A.A. anniversary, I began to feel that our sponsor/sponsee relationship had become tentative. Dick traveled a lot for business, and often wasn't available to talk in-person or by phone.

At the same time, Don C. was attending many of the same A.A. meetings that I did, and he almost always had something profound or timely to share in his comments that helped me. After thinking it over, I finally had a chance to talk with Dick and said that I was interested in asking Don C. to be my new sponsor. I remember how I tried to "let Dick down easy; it wasn't him...it was me!" Dick laughed and said it was no problem, and that Don was a great choice as a new sponsor. Besides, Dick was planning to retire and move to Florida soon, so this was all for the best.

When Don said he would be glad to be my sponsor, a powerful chapter in my sobriety began. Over the years, Don became more than a sponsor; he was my friend, my wife's friend, and an important voice of reason in my life. We were among his closest friends to be there when Don was hospitalized for an operation,



and a few years later when cancer took hold of him and eventually ended his life.

I was 20 years sober when Don died, and I had to mourn the loss of my friend, my mentor, and my long-time sponsor. As time went on, I realized that I had to face the question of what I would do about sponsorship. Honestly, I didn't WANT to have to find another sponsor. No one would know me like Don did. What if my new sponsor wanted me to do another Fourth and Fifth Step, just because that's what sponsors do?

My dislike of having to find a new sponsor led me to several years of "undercover sobriety." I went to meetings, helped others when I could, but didn't bring up the fact that I didn't have a sponsor—or that I didn't want one.

But I knew that something important was missing from my program—accountability and vulnerability. I needed to find someone who would get to know me, and be comfortable calling "BS" when I tried to be less than honest.

I started to open up at meetings that I was looking for a sponsor, and after some time, asked Paul C. to be my sponsor. Well, it wasn't much longer than a few months before Paul decided to move to Arizona, and I was sponsor-less once again.

I began to talk about needing a sponsor again at meetings, and after a meeting at the Serenity House in Libertyville, Jim M. offered to be my sponsor. He is my sponsor today, and has given me some good advice and encouragement.

My advice to anyone who may find themselves in a similar situation some day, would be to mourn the loss of your former sponsor, but push yourself to find someone else. They won't be a "replacement" for the former sponsor; they will be the person whom your Higher Power has put into your life when you needed it. —Tom K.

Through displays, supplies of A.A. catalogs and order forms, and A.A. literature workshops, this committee helps A.A. members to carry the A.A. message through our literature. The Literature Committee also produces Beginner Packets which are made available to groups to provide to newcomers.
