The 2016 Spring Assembly is April 2<sup>nd</sup> it's part of the 2016 Spring Conference. There is no registration fee to attend the assembly; but if you want to stay and enjoy all that the conference has to offer, you will need to register for the assembly. There will be onsite registration at the conference.

I have been in contact with the 2016 State Conference planning meeting. They/we have some alternate positions that need to be filled. The open positions are: Alternate Secretary, Alternate Treasurer, Alternate Registration Chairperson, Alternate Printing Chairperson, Alternate Hospitality Chairperson, Alternate Coffee Chairperson, Alternate Decorations and Dance Chair\* and Alternate. I did receive a thank you from the 2016 Spring Conference chair for the \$100.00 donation to the Hospitality room. **Alt DCM:** (Bob P). As per the February District 10 meeting, (20) "A.A. Service Manuals" were purchased from the Chicago Area Service Office for a cost of \$80.00. Judd W., NIA 20 Treasurer, reported a price increase for copies since the merger of Office Max and Office Depot: In the past, single sheet copies cost \$.035 per copy with double sided copies costing \$.07 each. Since the merger, double sided copies cost \$.28 each, with the single side copy cost remaining at \$.035 each. Judd is trying to negotiate. He suggests Area 20 districts be aware of this increase.

Through the months of January and February, 2016 7<sup>th</sup> Tradition group contributions totaled \$13,343.00. Of this, District 10 contributions were \$805.00 with 11 groups contributing. The grand total of contributions to NIA 20 was \$15,405.00. NIA 20 expenses were \$8981.00.

Service Sponsor encourages the individual member interested in this form of service to attend district meetings and to read about the history and structure of Alcoholics Anonymous. At this point, the individual beginning this work should begin to understand the responsibilities of service work, as well as feel the satisfaction of yet another form of Twelfth Step work. Such individuals should be encouraged to take an active part in district activities and consider being elected to alternate positions in the district so as to learn about the responsibilities of various jobs in the <u>service structure</u>. During this process it is important for the individual to continue to learn about the Three Legacies — Recovery, Unity and Service, and to understand that the principle of rotation not only allows them to move on in service, but also gives newer members the privilege of serving. Rotation also allows them to understand that no one should hold on to a position of trust long enough to feel a proprietary interest and thereby discourage newcomers from service.

**TREATMENT** (Michael L., Alt. Steve B): Meeting at Gateway in Lake Villa on Friday nights at 745 PM (men's meeting in the men's building; women's meeting in the women's building needs support). Also need a volunteer to chair the men's meeting; rewarding service work.

**WEBSITE** (Earl N., Alt. Steve K.): First, my apologies for missing the past two meetings. We have our analytics back. In the past month we have had 1810 visitors who viewed 4547pages. Our demographics of those visitors who allow Google to anonymously track them are similar to other months.

55% of our visitors are male, 45% female.

62% of our visitors are 34 and under (27% 18-24 and 35% 25-34).

The vast majority of our visitors go to the homepage first and then to a meeting day page. 62 of our visitors went to the calendar page. Our Bounce Rate (people who only visit one page and leave) is incredibly low at 1.34%. Two behind-the-scenes activities are moving forward. We are working to develop two new databases to be shared privately on the web with GSRs and chairs - the list of locations and members responsible for our business cards and a master list of all group GSRs; more on this in the next few months.
