DCM (Chuck D.) Not able to make the Winter Assembly yesterday, so I asked Bob if he could attend on behalf of District 10. As a reminder if everyone active AA member were to send \$7.14 to GSO literature would be free.

Alt DCM: (Bob P)-At the request of Chuck D., on December 11, 2016, I attended the NIA20 Winter Assembly at Lord of Life Church, in La Fox, IL. The 2017 Area 20 calendar was set after District 79 (Rockford Spanish Speaking District) volunteered to host the August 5th Committee Meeting. No districts stood to present bids for the 2018 Spring Assembly/Conference. In 2014, Districts 10, 11 and 12 hosted the Spring Assembly/Conference at the Gurnee Holiday Inn.

Area 20 Delegate, Kelly L. presented her report. The proposed agenda items for the 2017 General Service Conference appeared in her report. The Area 20 "Pre General Service Conference Workshop will be held on April 8, 2017: This is where the delegate will hear the group consciences from the 25 individual districts and approximately 37,000 alcoholics. The Trustees' CPC/Treatment and Accessibilities Committee agreed to forward a recommendation to the 2017 CPC

Committee that the pamphlet "Three Talks to Medical Societies by Bill W." will be retired due to dated language. September sales are ahead of budget with actual gross sales \$1.2mm which is 5.4% ahead of plan. Total AAWS Online Bookstore September sales stand at \$701k. Total e-book sales are \$790k. All figures are through September, 2016. The Grapevine and La Vina book prices will be increased at \$.50 each starting March 2017. Grapevine sales are ahead of plan through September, 2017.

The treasurer reported NIA20 2016 taxes are done with no penalties and is in good standing with the IRS and State of III. The prudent reserve is at plan with \$6k sent to the GSO to fund NIA20's delegate's seat at the GSC.

A motion by Area Webmaster, John C. was discussed at length and passed. The motion proposed annual attendance by the Webmaster or Alternate at the annual A.A. information technology conference/workshop.

Ray M., Area 20 Archivist, presented an interesting report. There is now an "App" for A.A. Archives. The Area 20 January 14, 2017 Committee Meeting will include a Service Workshop. All NIA 20 alcoholics are invited and encouraged to attend. In the DCM breakout, there were 21 present. No districts had strong opinions on whether to "split" the Spring Assembly/Conference back into separate functions. The DCMs will craft a motion to suggest an addition to the guidelines to provide time and space for individual breakout committee meetings at the Spring Conference. District 79 expressed concerns that no Spanish speaking meetings pop up at aa.org It was suggested the districts might try to fill the gap.

Visitor Presentation: Sid ISCYPAA Outreach Chair. ISCYPAA is an annual Alcoholics Anonymous conference held in the state of Illinois. It is an event for any and all members of AA, and is organized primarily by young, recovering alcoholics. We define young as "room to grow". ISCYPAA Conference will be held in Lake County Illinois for the first time ever. Date for ISCYPAA Conference February 24 – 26, 2017 at the Holiday Inn in Gurnee. The conference is hosted by Young People of AA all members of any age can attend. There are many opportunities to volunteer to help them have a successful conference. PRE-REGISTRATION is \$10 before December 31, 2016 or \$15 after January 1, 2017 you can register at their website at ISCYPAA.org. The speaker is Robbie W from New Jersey and Tina H. from Kenosha.

4. We hosted a "GSR Workshop" in October of 2015 where Marilyn Finn from Area 20 presented.

- Public libraries in the District 10 service area were stocked with replacement copies of *Alcoholics Anonymous* (the Big Book), *12 Steps & 12 Traditions* and *Living Sober* in fall, 2016. Portions of the orders were requested in Spanish.
