## My Grateful Journey

I now have gratitude for the program of Alcoholics Anonymous. I wasn't sure about all this when I first came into the program. I learned my fears were very common. I just wanted the "pain to go away." I should have done as I was told on day one; "get a sponsor" and read the first one hundred and sixty four pages of the Big Book.

I struggled along trying, but I was fearful of being labeled "stupid" because I just didn't understand! I made such an ordeal out of my early recovery. I learned and memorized the twelve traditions, and hung on to the third one as my "savior" - the desire not to drink.

I still didn't understand the thing about twenty-four hours; it was just too simple for this important person LOL!!! When my A.A associates told me it gets better, I didn't trust them! I had always relied on myself. And this "GOD" thing....it was beyond my realization. Why should he do anything for me? I never did anything for him; I was still caught in that mode of "Do for me, and I'd do for you." When I finally got a sponsor, it was because I could "hear" him. He helped me to better understand the simplicity of the A.A program.

And so step three entered into my life, and as it says, "I asked God to relieve me of the bondage of self." Next, my first sponsor had me not only read daily, the third step prayer on page sixty-three of the Big Book, and also read pages twelve and thirteen of Bill Wilson's story. Today, these readings have developed into something different from when I first started.

Today, I not only trust God, but my fellow A.A's whom I've also come to love unconditionally. I rely on God and other A.A's to steer and direct my thinking, when I start to veer off course. That is what I am most grateful for today. So if you haven't yet read the Big Book of Alcoholics Anonymous, I heartily suggest you do so. You might pay particular attention to the parts in italics! That third tradition is good to hang onto since no matter what I've done in the past, those things are forgivable because I stopped doing them. Trust in infinite God, rather than my finite self!

I keep coming back to meetings so I don't forget those things that got me into trouble; the things that got me here. I understand the Big Book's page one sixty four so much better, as I am trudging along on this journey. May God bless you all on your journeys!



### In all our affairs

A while back, I had an "awakening" of sorts, I'd like to share with our fellowship. It wasn't so much spiritual as it was more along the lines of a "frying pan" over the head awakening! This coming September will mark our 28th wedding anniversary. (just another miracle in this program.) Of course the "frying pan" is just a metaphor for what she really struck me with...reality!

With the kids off at college and busy in our careers, we find ourselves with more time to spend together. Now what should come natural to most, an adjustment to the schedule of our lives in order to accommodate the extra time with each other, came with a little more difficulty for this alcoholic. I was up to 4 sometimes 5 meetings a week, not including time spent at district, time spent with sponsees, Area 20 AA events, giving rides.... You get the picture! Mr. AA had certainly done enough 12-step work but had not figured out that he was neglecting the last part of the last step.

I had a spiritual awakening many in fact over the years. I had tried to carry the message to the alcoholic who is suffering and thought I was practicing these principles in all my affairs, but low and behold there was my wife sitting at home waiting for Mr. AA to come home and grace her with his company.

I talk about this because it s so easily done. Very unconsciously we forget to include the other parts of our lives that we need to pay close attention to, my wife. My wife pulled me back to reality by saying and I'm paraphrasing, "hey...remember me?"

You will not only find this warning of over-the-top zealous behavior in our big book but our co-founder Bill Wilson speaks extensively about it in dozens of grapevine articles which this over zealous alcoholic probably has read two dozen times!

Oh well, God willing I'll have a few more years to practice.
