<u>Sound Advice</u> by Rick S.

I never had to look for an AA sponsor. He was already there, waiting patiently for me. Halfway through a five-day inpatient detox, he and another fellow came to my hospital room and sat next to my bed, doing what Bill and Bob did with Alcoholic #3. The second guy looked very serious, but my future sponsor had a grin on his face. I wanted "what he had" for years before that day. I had known him before his recovery, and in sobriety, he was a changed man. Whatever he had, I wanted it, and I didn't want to hurt any more. So, we walked through the Steps and went to meetings together. He recommended actions and literature that had helped him, but he did let me learn through my mistakes.

Back in 1974, after mindlessly pushing wheelbarrows and shoveling dirt and concrete for others, I had the opportunity to work side-by-side with an old German concrete man. It was him and me (I know; it should be "he and I", but that is not how I talk!) working as a team of sorts, day after day in all kinds of situations. From the very first day, he started to teach me the trade and the art, patiently and fairly lovingly, although we were two stubborn "Krauts" and I'm sure I tried his patience on many occasions! We also became close friends. I am forever indebted to him for what he did.

Unfortunately, alcoholism took control of my life and we parted ways. He was there for me again in 1985 when I went into business for myself, but again, we went our separate ways.

What's the point? The point is, I would not be as successful in my business as I have been, without that man's help, time, kindness, and patience, just as I would not be where I am in my sober life without my sponsor to show me the way. Of course I am also grateful for my Higher Power, who is in charge of all this, and the fellowship of Alcoholics Anonymous, which helps me grow in many ways!

If you are new to AA (or not new) and feel rudderless amongst a sea of fellow sufferers, please do not deny an alcoholic who has recovered the opportunity to enrich his spiritual life by sharing his journey with you by being a sponsor.

"Practical experience shows that nothing will so much insure immunity from drinking as intensive work with other alcoholics" says page 89 in Chapter Seven of our Big Book.

I have been blessed many times by men who share the journey with me. My first sponsee just celebrated his 16th anniversary of sobriety. I was only 6 months sober when I began to sponsor him, and was on my 7th Step when God allowed me to grow in this way. I think this was one way that God was beginning to remove shortcomings from me! This was a guy that I had drank with, in years past, and my sponsor knew him, too. My sponsor said "Well, I guess you can't hurt him none" and I believe he was right.

And that old German cement mason? That's another story for another time.

Step 3 Story

Made a decision to turn our will and our lives over to the care of God as we understood him.

I came into the program a self-proclaimed atheist. I did not believe in God one bit. Step one was not an issue, I knew it was over, I knew I could not continue to live like I was living.

In the 2nd step I had a white light spiritual experience. Not to be confused with a spiritual awakening, which in my life was two very different things.

Step three still scared me, it had the God word in it and even though he had introduced himself in step 2, I was still scared of him, including saying his name out loud.

My 1st sponsor had me learn the 3rd step prayer by heart, then we prayed it together. There was action in that. Remember, I was a self proclaimed Atheist. I had never prayed in my life. Funny, I recall when people would say "I'll pray for you" I always thought that was just something people said, turns out they actually do! At least I know I do.

My sponsor tells me that the 1st 3 steps are about alcohol, and in the beginning I believe that's true. I need to make a decision to turn my will (Thoughts, thinking about drinking) and my life (Actions, actually drinking) over to the care of God, as I barely understand him. I can make a decision to hand God my drink problem. I did that, then took the action in the rest of the steps to change and grow and leave the drink problem in his hands.

Now, fast forward a few years. Today I make a decision to turn my will (Thoughts) and my life (Actions) over to the care of God, as I have come to know him much better and have formed a working relationship with him.

Having spent a great deal of time in prayer, being of service and trying to live these principles, I have gotten much closer to this God I found here. So close that I ask him for help all through out my day. From what may appear to be the smallest thing, to the big decisions in my life.

By asking I am making a decision to accept his guidance, to guide my thoughts (will) and my actions (Life). When I do that I have a much easier time walking through the hard things and gratefully accepting the good things.
