## Spiritual Solution

To begin this page, my name is Dawn and I am an alcoholic (Hi Dawn). I have been sober 14 years and my sanity is constantly contingent upon the maintenance of my spiritual condition (page 85 BB). I am truly grateful for sobriety and have worked these steps like my life depends on it because I believe that it does. Spiritual bankruptcy can be a gift in the sense that the desperation that followed allowed me to be so open to anything that anyone said when I came here, and I listened. I've been to so many conferences and listened to thousands of tapes and CD's but I never remember who said what, "Learning to live life someone else's way" and "GOD = Gift of Desperation". "Trying to control being out of control". These are all things I learned when I was accepting my disease and learning about needing you all (and a HP) to help me.

I don't know about you, but, when I looked at the group that was going to save my life at the Alano Clubs in 2000, I was scared. No one had a real name. Everyone was either their day job then their first name (Concrete Rick) or a memorable characteristic (Slow talking Dan or Dancin' Mike). I wasn't sure what to think of all of this. I had a lot of wonderful women in my sobriety circle of friends including my sponsor, Nancy M (who has since passed). Nancy was my rock and still today I listen to her suggestions. I had 24 hours to get over something, period. Seriously. She truly believed (and she's RIGHT) that alcoholics cannot do anger and resentments and we better get over this stuff quick or we'll drink and to drink is to die. So, I learned how to do Steps 4-9 pretty fast on situations if needed within 24 hours because resentments and anger were not going to be a continuous part of my recovery program.

I actively participate in prayer and meditation every day. I get up in the early a.m. every day and read something that is 12– step related or the Big Book and I journal. I ask God for help and I sit in silence. I attend silent retreats. I calm this crazy mind. I have to. I give my day to God before stepping out the front door and try to leave it with him. Sometimes, I take control back before 10 a.m. and I need to do the serenity prayer at work again. It's just how life goes. We are given great tools to keep us aligned with a power greater than ourselves at all times. We are never alone. I am always a text, phone call, or prayer away from serenity and peace.
