I have had a number of years sober in the program, enough to have done more than one Fourth Step. At first, dragging those skeletons of the 50-year-old adolescent I was, when I first reluctantly stumbled into my first beginner's meeting, seemed not only daunting, but pointless.

"When are you guys gonna start talking about how you learned to drink normally?" I sat there thinking. "What, we have to stop altogether, and the Fourth Step will open the door to a

better life?" What was this stuff? I thought.

But God knew more about what I needed than I did, and fortunately, I came back to enough meetings to see the benefit of clearing out that "mental closet," and inventorying it for the worthless baggage it was, while learning a "whole new" way of thinking!

It never occurred to me that having one foot in the past, and one foot in the future, had me squatting on the present! Learning to



think another way; to have a different more positive perspective gave actual color to life, which was truly vibrant, peering out through the eyes of a "sober mind." A stark contrast to the meaningless drunken gray seen through the "blood shot," ungrateful eyes of the alcoholic.

My first Fourth Step cracked the door open, and each subsequent one thereafter, opened it further to the point where I understood that I would have sold myself well short, if at that first

meeting, they had taught me a way to drink safely.

Thank God for the program of Alcoholics Anonymous, where learning not to drink is just the door prize! The real gift is a whole new life full of unimaginable blessings that "rocket us into the "new dimension" of life, promised in the Big Book. Thank You, A.A.!

## Step & Tradition Four: Inventory and Autonomy

#### Step Four

"Made a searching and fearless moral inventory of ourselves."

#### Tradition Four

"Each group should be autonomous except in matters affecting other groups or A.A. as a whole."

The A.A. book, *Twelve Steps and Twelve Traditions* states the following about Step Four: "Creation gave us instincts for a purpose. Without them we wouldn't be complete human beings. [Yet] these instincts, so necessary for our existence, often far exceed their proper functions."

Step Four is our way to discover how our instincts and desires have warped us, so that we can move toward correcting them.

Like lancing an infected wound, the step may cause short-term pain for longer-term healing. We must face our past fearlessly, trusting that our Higher Power will help and guide us—if we ask.

Tradition Four, according to the "Twelve and Twelve," allows each A.A. group autonomy in decision-making, so long as the decision doesn't affect other groups or A.A. as a whole.

As the "Twelve and Twelve" states, "We saw that the group, exactly like the individual, must eventually conform to whatever tested principles would guarantee survival. [Every] group had the right to be wrong."


This tradition resulted from years of learning what can enhance or hinder an A.A. group. Autonomy for the group, with accountability to other groups and A.A. as a whole.—Tom K.

How Was I Supposed to Know That 'Archives' Is a Lot More Than Just Collecting Some Old Stuff From the District, and Making Sure It Gets

Put Into Storage...

This past November, when the District was holding elections for Committee Chair positions for the coming year, "Concrete Rick" S. volunteered to take the position of Archives Committee Chair. At the same time, they were of course looking for someone to fill the position of Archives Alternate. I liked Rick. He had been a friend for a long time, and I had enjoyed working with him when he chaired the CPC committee. So I figured what the heck, and volunteered to be the Archives Alternate. At the time, I thought "how hard can this be"? Archives doesn't really do that much. They just collect a lot of old stuff from the District and put it into storage. I can do that. And anyway, it's Rick's problem. I'm just there so he won't have to feel so alone. Boy was I in for a rude awakening.

The first thing Rick wanted to do was go through the storage locker and see what was there. I can tell you this, there is a LOT of stuff there. District 10 GSR meeting minutes and copies of the Conscious Contact, and budget requests and paid bills...and a lot more...dating all the way back to the early 1980s. More than 35 years-worth! In going through all this with Rick, it occurred to us that we were now the custodians and guardians of a great deal of our A.A. "history" and were obligated not only to preserve these materials, but to add to them during our tenure. It looked like this might turn out to be a bigger job than we thought. In a very real sense, we were now part of the process of "carrying the message" of Alcohol-

ics Anonymous to members of the fellowship who would come after us. Who knows, maybe 35 years from now someone will want to look back and see what we were doing in District 10 way back in 2017, and for that: we are responsible.

In addition, Rick wanted to "update" the Archives Display for District 10 that we would be making available to be viewed by the fellowship at various AA venues, including the Spring and Fall Breakfasts, McHenry Soberfest, and perhaps other events that would like to have this kind of display available. To that end, we started collecting materials from storage that would represent AA and District 10 in a truly interesting way. There was no shortage of materials to work with, including old "Grapevines" (some dating back to 1951), a meeting "ledger book" that shows income and expenses for one of our Avon Township groups from 1987 to 1998, a copy of an article written in 1946 in the *Scientific Temperance Journal* about this "new group" calling themselves Alcoholics Anonymous, and of course a lot more. If you want to see the new "updated" Archives Display, it will be at the Spring Breakfast being held at Bonnie Brook Golf Course on April 9. We hope you will make it a point to stop by.

"At the 2012 [National A.A. Archives] Workshop in Cocoa Beach, FL, General Service Office archivist Michelle [Mirza (nonalcoholic)] met a district archivist who showed her letters between an editor named Janet Blair (a nonalcoholic) and Hank P., Bill W.'s business partner at Honor Dealers in Newark, NJ.

Blair was an early editor of at least the first sections of the Big Book; her work earned her a letter of thanks from Bill himself, as well as a signed First Edition."
