One of the agenda items that will be discussed during the April 22-28 68th General Service Conference of Alcoholics Anonymous in New York will be a request to add the A.A. Preamble and Responsibility Statement to the book, *Alcoholics Anonymous*.

The Responsibility Statement is printed on page 1 of this newsletter, to the left.

The A.A. Preamble touches on a topic that I have heard mentioned several times in recent weeks; that is, whether A.A. groups are being insensitive or intolerant when they end their meetings by reciting "The Lord's Prayer."

The A.A. Preamble includes the statement: "A.A. is not allied with any sect, denomination, politics, organization or institution; does not wish to engage in any controversy, neither endorses nor opposes any causes. Our primary purpose is to stay sober and help other alcoholics to achieve sobriety."

Do we ignore that part of the A.A. Preamble when we end an A.A. meeting with The Lord's Prayer? That question was raised recently by the editor of *Concepts*, a quarterly newsletter published by the Northern Illinois Area of Alcoholics Anonymous.

In that issue, the "Editor's Corner" and a separate article titled, "Atheists in A.A.," caused me to consider how someone who is not Christian might be taken aback by being asked to recite a Christian prayer in an A.A. meeting. For transparency, I want to state that I am a life-long Christian. I have always been comfortable reciting The Lord's Prayer in A.A.

But the Concepts articles and recent comments from non-Christians in A.A. meetings that I have attended prompted me to bring this question up in our District 10 newsletter.

Talk about it in your group meetings. If you can, send me your thoughts on the topic.

My hope is that A.A. continues to be a tolerant place where anyone who has a desire to stop drinking can find hope and support.

## Musings on Step 3 and My Place in the Universe

Although I had no formal religious training as a child, I was taught to believe in, and pray typical children's prayers, to a God that I envisioned as an old, white-bearded man. The message conveyed to me by my family was that I was a special person who was entitled to all I wanted-if I could figure out a way to get it, one way or another. I did not have a very close relationship with my mother, but idolized my father, who was 55 years old when I was born. He was 20 years older than my mother, and an extremely hardworking, hard-playing, hard-drinking authoritarian who did not spare the belt and had a scary volatile temper. A combination of genetics, anxiety and circumstances allowed me

to begin my alcoholism at an early age. My parents did not discourage what they knew of my drinking; not that it would have made any difference, as I had what today would be diagnosed as Oppositional Defiant Disorder. In plain English, I was a belligerent, spoiled brat. The philosophy of "Do it to them before they do it to you," served me well, I thought, for many years. I always got what I wanted, and believed that if I did something, it must be right because I did it. I probably crossed the line from alcohol abuse to addiction at some point during my college years. By age 24, I was married with two children, a rising star in my profession, running the (Continued on page 2)

And then my father, who never missed a day of work, was stopped by congestive heart failure. I prayed to God to make him

well, and he got sicker. I prayed to God to take him home, and he lived and suffered. I fired God. God was in charge of everything in the world except me, and if He couldn't comply with a simple request, what good was He?

I drank and drugged and behaved reprehensibly for another 21 years. When my body and mind were both broken, I threw my hands up and begged, "Please God, help me." I had no fight left

want for myself or anyone else (but I do offer a preference at times). I am no longer God's equal. I pray for the strength to stay sober and to get through any challenges life brings. I go to God now with love, respect and confidence, rather than fear and anger. I try to do my part knowing that He will do His. I don't have to be the best, have the most or pretend I am what I am not. As my dear friend, Ev, says, "It's good to get up in the morning and ask God what we're going to do today." —Mike B.
