## Support Open, Closed and Struggling Meetings

Occasionally we hear from members of meetings where attendance has dipped. Sometimes, as in the case of the 8 a.m. Saturday Big Book meeting at 595 N. Deerpath Drive in Vernon Hills, it could be due to a change to a different location that wasn't regularly communicated.

We can't always list meetings which need support, but we did, for example, publish an article earlier this year when all of the meetings formerly at Berger Hall moved to new locations.

While on the subject of meetings, we heard someone recently explaining to a newcomer the difference between "open" and "closed" A.A. meetings. In case someone new to the program reads this, here is a brief explanation of the difference.

Open meetings welcome anyone who wishes to learn more about the A.A. program and recovering from alcoholism. Open meetings within District 10 include the 11 a.m. Sunday morning speaker meeting at Serenity House in Libertyville and the 8 p.m. Saturday speaker meeting at the Round Lake Alano Club in Lake Villa.

Closed meetings are for people who have a desire to stop drinking.

Very occasionally we have been part of a closed A.A. meeting where the group voted to allow a nonalcoholic to attend the meeting. That requires a group conscience.

## Anonymity Intact, A.A. World Services Launches YouTube Channel

Balancing the desire to connect with people appropriately on social media while maintaining A.A. Traditions including those centered on anonymity, A.A. World Services has launched a YouTube Channel.

Reporting during the A.A. World Services Board meeting on Thursday, July 26 at the General Service Office in New York, members of the Technology/Communication/Services (TCS) Committee said subscriptions to the A.A.W.S. YouTube channel have increased to over 1,300—with new subscriptions daily. (At the time of this issue being printed, the number of subscribers had increased to more than 1,500.)

The TCS Committee also provided an update regarding work on a new website design for A.A. The new website design contin-

ues toward a final site map, along with development of a creative brief and mood boards.

# Selected Highlights from the July A.A.W.S. Meeting in New York

Polling of General Service Conference members was undertaken to resolve a discrepancy with the scheduled dates for the 2019 Conference. The polling took place between July 9-22, with 100% participation. [The final dates for the 69th Conference are now confirmed for May 19–25, 2019.]

A site visit to Detroit for the 2020 International Convention will be held in September. Site selection for the 2030 International Convention continued with site visits to the two finalist cities by the committee. Convention consultant Gregg Talley reported spending significant time working with both Indianapolis and St. Louis in preparation for the 2030 site visits with the A.A.W.S. team.

Finance – Sales through the first six months of 2018 were below budget, while contributions were ahead of budget. Regarding variances between the 2018 budget and year-to-date results, the following areas were noted: Revenue: For the six months ended June 30, 2018 revenue was 0.91% higher than budgeted and 2.04% lower than the six months ended June 30, 2017. Operating expenses were 2.66% greater than budgeted and 11.87% more than last year. Unit book and booklet sales have decreased from 2017 by 18,815 pieces or (2.18%).

<u>Contributions</u>: Actual contributions for the six months ended June 30 were \$3,816,472, which is 3.77% higher than budget and 1.19% higher than the six months ended June 30, 2017.

Online contributions for the first six months of 2018 amounted to \$369,067. This compared with \$333,480 in 2017, \$212,908 in 2016, \$179,449 in 2015, and \$135,909 in 2014. Online contributions for the first six months of 2018 account for 9.80% of total contributions. Expenses: For the six months, salaries were \$77,921 (2.20%) more than budget and \$379,034 (11.70%) more than the six months ended June 30, 2017. Several more positions have been filled in the first six months of 2018 as compared to the same period last year.

International – Preparations are in high gear for the 25th World Service Meeting. Currently 69 delegates from 43 countries are expected to attend. Several countries have generously contributed additional funds to provide financial assistance to countries that have asked for help in funding their W.S.M. delegates.
