

Staying Out of Myself Daily.

I wondered about the 10th step in my first 6 months of sobriety that started August 4th, 1993. I just started my fourth step of writing down my inventory. My life had taken a turn for the worse with my current relationship with my soon-to-be former wife. It really felt weird to be communicating with her sober. It was an interesting



The purpose of the 10th step is to work your program daily with all people, places, and things. Meeting with my sponsor was the key to working the twelve steps in order. He shared his experience regarding the importance of taking a 10th step daily inventory every morning. I was to review where I have been wrong in all facets of my new sober life and try to communicate my new message to my loved ones when I was wrong. It was my first attempt to be honest and has saved me many times from having to make the same amends repeatedly.

When I read our 10th step in our 12&12 book, I am reminded of another alcoholic like me who was affected by the "big-shot-ism" attitude. Life today has been challenging, even after 30 years sober. You might ask me, "why?" When I do not work this step daily, I get in the way of myself, and all associated with me. Promptly admitting I was wrong is the key to staying sober per my experience and is good medicine to take repeatedly.

By finding a new balance with my Higher Power and sharing my experience, strength and hope related to working the 10th step, I am better able to help still suffering alcoholics. We can do this together, and I suggest not complicating the step.



Relying on God to Fulfill My Daily Responsibility

My "step 10" was often, "Continue to see who was looking, and when I was wrong, promptly deny it!" I often sought to disguise, misguide or otherwise deceive others into thinking all the things I had done were "OK," "not all bad," or "not really my fault." But, it's kind of like the message Jimmy Buffet had in Margaritaville, "Some people claim that there's a woman to blame...but I know...it's my own damn fault." It wasn't until I fully accepted my actions as being fully my responsibility that I surrendered to my Higher Power, God, and trusted him to lead my daily actions. Only then, was I actually able to honestly continue to take personal inventory and when I was wrong, promptly admit it.

Today, it feels so much better to own up to my shortcomings, errors and misguided judgements, and confess where I have stepped out of line. The whole purpose of the 10th step is to recognize more quickly where and when we have done or said something that could be considered hurtful, discouraging, resentful, or damaging to another. Then, we can correct the error of our way. Better yet, through practicing the 10th step, we can recognize where we might be starting to make an error and pause...reflect, think and consider the ramifications of our action before it becomes the "wrong" we will need to promptly admit.

May we start our day with a spiritual conversation with God, asking for his guidance for our day, to help avoid making judgements that may hurt others, to recognize the need to pause, and to take that opportunity (more often) to enrich our soul, improve our disposition and strengthen our resolve toward becoming the people God originally designed and intended. Blessings and best wishes for your day!

Continued to take personal inventory, and when we were wrong promptly admitted it.

We have not even sworn off. Instead, the problem has been removed. It does not exist for us. We are neither cocky nor are we afraid. That is our experience.
