SECRETARY'S REPORT (Dawn Rene W) Minutes from previous meeting. DIRECTLY FROM REPORT

Please be reminded that the budget for the Secretary position was set a bit lower than reality is playing out to be. Based on an average of \$30 for the past few months, May through December will need \$240 to make it through until the next budget session gets worked on. Thanks to our tech team, I have been introduced to a new way to share documents and flyers with you. I hope attaching hyper-links instead of documents will work well for everyone.

Kevin A motioned to increase the Secretary budget from the annual \$100 to annual \$500. Motion passed.

Eric L moved to approve Minutes for April GSR meeting. Motion passed.

TREASURY REPORT (Erik W.) DIRECTLY FROM REPORT

A category for PayPal fees was added to the Treasurer's Report. Cindy moved to approved. Motion passed.

DCM's REPORT (Lorrie F.) DIRECTLY FROM REPORT

Our delegate, Erik Long, is back from New York and will have his complete report at the assembly next month, June 22nd. Also, Erik will be attending our July District meeting (7/28) to give his report and you will have time to ask questions. With that said, in order to have time for his report and to adjourn within an hour, any committee reports that are usually given verbally will need to be available in paper copy for distribution unless publishing in the minutes will suffice.

I attended the Area 20 Committee Meeting via zoom. Here are the highlights:

- Contributions are up for GSO 2.8%. Thank you to the fellowship.
- Literature Gross Margin at GSO was the primary contributor to the financial loss and the need to dip into the reserve fund.
- GSO will remain in its present New York City location. There will be some renovation and consolidating of levels of offices to keep costs down.
- Plain Language Big Book final draft was approved. It may be available this fall.

MOTIONS: 2 Motions were read. They are not complete and corrected however, please take this back to your groups as this will be once again read, corrected and possibly voted on at the June assembly.

Motion to write a letter to the General Service Board, requesting to amend the Conference Charter to include Founders

Literature Panel 64 Past Delegate moves to request that the Panel 74 NIA Delegate forward a letter to the General Service Board, prior to the 2024 deadline, with a request amend the Current Conference Charter, Section 3, paragraph 2, to include the "Founders Literature" of the books Alcoholics Anonymous and Twelve Steps and Twelve Traditions. That in addition to this amendment, any changes to the books Alcoholics Anonymous and Twelve Steps and Twelve Traditions, (1953) be returned to its originally written wording.

Motion to amend Corrections Workbook M-45 Panel 74 NIA 20 Corrections Chair moves that we amend the "Corrections Workbook" to read "The only purpose of the pink can is to provide G.S.O. Conference-approved **or Grapevine published** literature." This policy comes from page 18 of the "Corrections Workbook" (M-45), section titled "Area 10 (Colorado) Seventh Tradition Support", second paragraph, third sentence.

There are New Area 20 Service Manuals. I only have a few, so please come to the Assembly for a copy if you did not get one today.

Contributions for District 10 (3rdQ of '23) are shown on a complete Area 20 synopsis in a binder circulating. We only have contributions to GSO from 5.73% of our groups. Behind that is a complete breakdown of each group's donations.

There is also a binder with a physical copy of **Box 459**. This is now only available online. It will no longer be mailed for a savings of \$35,000. You can go to aa.org and view this at any time. This is another example of how GSO is trying to save money anywhere they can.

I have been chairing an Area AdHoc committee to create surveys for: GSRs, Committee Chairs and DCMs. This was created by the Area to help them better serve all of us by understanding where the Area might need to give additional assistance to help better inform our Area Servants. We plan on having these surveys available in print form at the upcoming Assembly in June, but prefer electronic answers. Links will be made available as it is easier to calculate the results. These will need to be completed by September for reporting results by December. I will keep you informed. I have been part of several meetings where we have bought and donated LaVina subscriptions to local libraries and the jails. Please consider doing this and donating to any Spanish speaking church in your area. Gateway said they have enough subscriptions right now. La Vina still needs our financial support.
