The process for volunteers to get clearance is available on the district website corrections link and the Conscience Contact newsletter. I recently logged in and revisited what is required. It is very doable, and I am willing to hold an in-person one-to-two-hour workshop (maybe at Serenity House). Please take this back to your home groups. The pink can fund is running low. Please announce to home groups that it has purchased Big Books, 12&12s and many other AAWS approved literature (all delivered to LC jail). The area meeting contact UR code has been attached on each inside cover along with the AA Preamble. Also remember to collect used Grapevine digests. I met with the Inmate Program Director earlier this month in the jail library. All donated items are getting into the hands of those in that care to learn there is a solution. (Currently there are about 350 beds out of 850 in use.) 350 I was informed they are working on having inhouse volunteer training.
