Corrections (Ted S) Alt. (OPEN)

Since chairing the Corrections Committee I have learned to serve in an atmosphere unknown to me. I had inspiration to do so by hearing another A.A. stand up in a meeting expressing the need for carrying the message to Alcoholics behind bars. Well, having rotated out of the Grapevine committee, I then attended corrections committee's breakouts at area assemblies. Then by no coincidence the National Corrections Conference took place at Woodfield in 2022. I was hooked. Shortly after, I went through the process to be allowed to bring AA to the LC jail (which took one year of sober patience to enter the facility) and McHenry County jails.

Bringing meetings to the Lake County Jail continue when requested and volunteers are available. Meetings are 7pm Mondays and Thursdays. I delivered a case of 20 Spanish version and another case of English soft cover Big Books to the jail last month. As the Pink Can funds continue, soon the new "Plain and Simple Language" – *A Tool for Reading Alcoholics Anonymous,* can make it to those who need the help in understanding the Big Book. Our Pink Can contributions totaling **\$1718.60**, purchased Big Books and other AAWS literature in the last two years specifically for the LC Jail. November 2023 with the group conscience, we sent Northern Illinois Area 20's Pink Can fund \$500.00. As of November 2024, Area 20 had \$3800.00. Many of the Illinois's institutions with over 300 in the southern area are benefitted by these contributions.

Reminder- please keep those used Grapevine digests coming. Collect them and bring to district meetings.

I attended the 7th Annual 2024 A.A. Corrections Conference last month in Charlotte N.C. The corrections committee budget paid for my cost of round-trip flight, lodging, and conference. It was the highest registered (400 members) to attend including those from Canada, Mexico, Alaska, Hawaii and more. The program; a week end full of fellowship sharing their experiences of incarceration, finding hope and sobriety behind the walls, and giving back the message by returning to jails, prisons, penitentiaries, treatment facilities with the A.A. message. Leaders in the courts spoke of their programs to help "alcoholics in jail "find new direction in life when released; hold on to and continue their spiritual sobriety. Just about every facility has their own start up stories and ways they do things. The bottom line is we AAs are privileged to be allowed to enter as special visitors.

The first AA meetings began in 1942 when the Warden at San Quentin learned the results of A.A. He believed that if only one could get sober and be a useful outside it was worth it. Today there are approximately 1000 institutions utilizing tablets with downloaded AA literature (including the new Plain and Simple Big Book before the soft cover book was released for sale).

-A special kind of A.A. service

The letter correspondence or "pen pal" to the incarcerated is another way of service. So far this year in the USA alone, the GSO received over 3000 letters from "inside" and 2300 outside "Pen Pals" that communicate the message. There are currently over 4000 active participants in USA.

I am so grateful to have been the chair and will continue to bring AA to the alcoholics on the inside. Ted.
