

# **Corrections Committee Closing Report**

Since chairing the Corrections committee, I have learned to serve in an atmosphere unknown to me. I had inspiration to do so after another A.A. member stood up in a meeting and expressed the need for carrying the message to alcoholics behind bars. Having rotated out of the Grapevine committee, I began attending Corrections committee's breakouts at area assemblies. By no coincidence, the National Corrections Conference took place at Woodfield in 2022. I was hooked. Shortly thereafter, I went through the process to be allowed to bring A.A. to the Lake County jail (which took one year of sober patience to enter) and McHenry County jails.

Bringing meetings to the Lake County Jail continue when requested and volunteers are available. Meetings are held at 7:00 p.m. on Mondays and Thursdays. I delivered a case of 20 Spanish version Big Books and another case of English soft cover Big Books to the jail last month. As the Pink Can funds continue, soon the new "Plain Language Big Book – A Tool for Reading Alcoholics Anonymous," can make it to those who need the help in understanding the Big Book. Our Pink Can contributions totaling \$1,718.60 purchased Big Books and other A.A.W.S. literature in the last two years, specifically for the Lake County Jail. In November 2023, with the group conscience, we sent Northern Illinois Area 20's Pink Can fund \$500.00. As of November 2024, Area 20 had \$3,800.00. Many Illinois's institutions – with over 300 in the southern area – are benefitted by these contributions.

I attended the 7th Annual 2024 A.A. Corrections Conference last month in Charlotte N.C. The corrections committee budget paid for my cost of round-trip flight, lodging and conference. It was the highest registered (400 members) and included registrants from Canada, Mexico, Alaska, Hawaii and more. The conference included a weekend full of our fellowship sharing their experiences of incarceration, finding hope and sobriety behind the walls and giving back by returning to jails, prisons, penitentiaries and treatment facilities with the A.A. message. Leaders in the courts spoke of their programs to help "alcoholics in jail find new direction in life when released; hold on to and continue their spiritual sobriety." Just about every facility has their own start up stories and ways they do things. The bottom line is that A.A. is privileged to be allowed to enter as special visitors.

The first A.A. meetings began in 1942 when the Warden at San Quentin learned the results of A.A. He believed that if only one could get sober and be useful outside, it would be worth it. Today, there are approximately 1,000 institutions utilizing tablets with downloaded A.A. literature (including the new Plain Language Big Book before the soft cover book was released for sale).

I am so grateful to have been the chair and will continue to bring A.A. to alcoholics on the inside. If you are moved – in the same way I was when another A.A. member spoke at a meeting – perhaps you will consider carrying the message to those that are incarcerated. Please continue to hold onto your used Grapevine digests and bring them to the next

district meeting. If anyone enjoys writing letters, there is more opportunity to serve via the Corrections Correspondence Service (CCS). CCS is a letter/pen pal correspondence service with the incarcerated. So far in 2024, GSO has received over 3,000 letters from "inside" and 2,300 outside "pen pals" that communicate the message. 



I no longer have to let my addiction decide what I do, where I go, and how I act. I say yes to life and thank my higher power and all the everyday angels that have guided me to this life of freedom. This is a daily practice of gratitude, action, prayer, and meditation. I am so thankful I no longer have to keep everything working perfectly and that I am able to let the God of my understanding run the show.
