# Baseball, Road Trips & Recovery

By the end of May 1990, I was totally burned out. It was not just work burnout — it was seemingly every area of my life. That meant even my program of recovery was suffering. I was attending my regular A.A. meetings, but I had allowed my disease to convince me that they were boring and that I needed a break.

I decided to make some changes in my life. I had just purchased my dream car—a sporty convertible two-seater—and was going to break it in with a little jaunt to Cooperstown, New York, to visit the Baseball Hall of Fame.

I had one last commitment: my sponsee's wedding. It was a huge outdoor event with all my Waukegan A.A. friends. It was a real-life, *boy-meets-girl-on-the-A.A.-campus* story. Although I was very happy for them, it was now going to be "me" time.

I left with my wedding clothes on, planning to change in a bathroom into my shorts and black T-shirt and hit the road to the Baseball Hall of Fame.

That night, I made good time and was in Pennsylvania by 2:00 a.m. I was tired and checked into a hotel with plans to hit the road hard to the foothills of New York and be at the exhibit by the next afternoon.

With a couple of gas stops and a call to my girlfriend, I was sitting in my car in the Baseball Hall of Fame parking lot. It was strange because there were only three cars in the entire lot. I walked to the doors, and a worker said I had 10 minutes before closing. I was confused; it was just 5:00 p.m., and the door said they closed at 8:00 p.m. That's when the worker informed me it was Memorial Day, and the Hall of Fame had shortened hours. He hoped I would make it back tomorrow when the regular schedule would resume.

I made a quick tour of the entire Hall, marking my spots for the next day. I was told it was closing, and I made my way out the door, right next to a young couple. We made a nodding acquaintance, and as they entered their car, I noticed they had Illinois license plates. "Where do you two live in Illinois?" I asked. "In the city, Logan Square," they said in unison. I told them that I lived in Waukegan. Before they left, I asked if they would be back tomorrow. Then I remembered that when I drove through town, there were no hotels or motels in Cooperstown. I asked them where they were staying. They told me there were only bed-and-breakfast places. I thanked them and said, "Maybe we'll bump into each other tomorrow."

The next day, I made my way to the Hall. I was pumped to plow through the entire place and all the major exhibits. Nobody with me, no distractions, just pure nostalgia and nonstop memories of my childhood. My dad would make little comments about how someday we would go to the Hall of Fame, but we never made any real plans. As I grew up, each summer would pass, and

As I grew up, each summer would pass, and we wouldn't make it to Cooperstown. I told myself it was better going alone. I wouldn't have to endure long car rides with my family, where my brothers would constantly annoy and poke fun at me.

After a couple of hours, I bumped into my Chicago friends. We walked together through a couple more exhibits and decided to take a break and have lunch. We found a hotel nearby with an all-you-can-eat buffet. It was there that I learned their names. The man was Russ, and his wife's name was Tish. As we made our way to the buffet, Russ led the line and proceeded to scoop generous amounts of food onto his plate. As Tish and I waited patiently, Tish blurted out, "Easy does it, Russ! Leave some for Ed and me."

She had said an A.A. saying, "Easy does it," and I suddenly became aware that this couple might be alcoholics in recovery. My Spidey Sense was tingling. I wanted to say something to see if they were involved with Alcoholics Anonymous. But I discounted my thoughts—come on, Ed, it's just a phrase, I thought. A.A. doesn't have a trademark on it. Besides, if they're not in A.A. and you ask, you'll feel really weird. They might think you're some crazy alcoholic and give you the cold shoulder for the rest of the meal, then ditch you as soon as you get back to the exhibit. It just wasn't worth it—I should drop it.

I couldn't drop it. Between bites of my food, I couldn't hold it in any longer, and it just came out: "Are you two involved with A.A.? Are you friends of Bill?" In that split second of hope and anticipation, their eyes lit up, and they said in unison, "Yes, we are! You too?" Relieved, I shouted, "Yes, I am too!" "How did you know?" they queried. "The 'Easy does it," I laughed with a smirk. "But anyone could use that phrase," they commented. "I know, I just went out on a limb, and my higher power pushed me to ask. I really didn't want to bring it up; it just came tumbling out of my mouth before I knew it."

We exchanged brief recovery backgrounds. They wanted to have a meeting in their room after the Hall closed, and of course, I agreed. They had their Big Book, I had my 24-hour book, and they had a Grapevine issue, which had the preamble. We were set to have a meeting. As we continued our exhibit walk, we decided to part but to meet at 8:30 p.m. in their room.

Here I was, doing everything in my power to get away from it all, including A.A., but my higher power pulled me back into the middle of the fellowship once more. It seemed that no matter how far I strayed physically, mentally, but mainly spiritually, the fellowship of Alcoholics Anonymous snatched me back to find my recovery in unity and service. In my recovery, no matter how far I roam, I am never alone.

### **Marty & His 3 Wives**

After years in A.A. and working through the steps, I reached my ninth step, which involved making amends to my two ex-wives. I had intentionally delayed addressing them, waiting for the right moment. By the time I felt ready, I had been working on my ninth step for years, even addressing an issue from 70 years ago. Here's my story.

My second ex-wife lived across town and knew I was in A.A. As a friend once said, "When Marty came into A.A., he jumped on it with both feet." Over 40 years later, I still remember that. I called her to ask if I could visit for a chat, and she agreed. I arrived with not just apologies but a check in hand. Over coffee at her kitchen table, I hesitantly began, eventually covering everything I felt needed addressing. I asked if she had anything to say. She shared a few thoughts and expressed pride in my A.A. journey and life changes. I suggested closing with a prayer, which we did, and I left on a positive note. Years later, as she battled cancer, she passed away, leaving me a message echoing that positivity.

My first ex-wife lived in Nevada, while our daughter lived in Sacramento, California. I visited my daughter twice a year and occasionally saw my first ex-wife. While on a ninth step roll, I coordinated a visit to my daughter's when I knew her mother would be there. After a few days, I invited my ex-wife to lunch and explained my intentions. She knew I was in A.A., but unlike my second ex-wife, she seemed uninterested. I shared my amends, she offered a brief compliment and a couple of comments, and that was it. I returned home and mailed her a check. She later called to thank me, saying it wasn't necessary. We still occasionally cross paths in Sacramento, exchanging brief updates about our daughter and granddaughter before going our separate ways.

In the intervening years, I remarried, giving me two ex-wives and a current wife. My neighbor Bob coined the phrase "Marty and his three wives" when my eldest daughter, then 47, got married in Sacramento. The wedding was a grand affair, and all three wives—my current wife and two ex-wives—attended. We sat at the same table, danced together, and my ex-wives shared hilarious and slightly embarrassing stories. Only in A.A. could such a moment happen. The next day, I treated everyone to a late breakfast. That's my story of working my ninth step and Bob's memorable line, "Marty and his three wives."

### The Twelve Steps

- 1. We admitted we were powerless over alcohol that our lives had become unmanageable.
- 2. Came to believe that a Power greater than ourselves could restore us to sanity.
- 3. Made a decision to turn our will and our lives over to the care of God as we understood Him.
- 4. Made a searching and fearless moral inventory of ourselves.
- 5. Admitted to God, to ourselves, and to another human being the exact nature of our wrongs.
- 6. Were entirely ready to have God remove all these defects of character.
- 7. Humbly asked Him to remove our shortcomings.
- 8. Made a list of all persons we had harmed, and became willing to make amends to them all.
- 9. Made direct amends to such people wherever possible, except when to do so would injure them or others.
- 10. Continued to take personal inventory and when we were wrong promptly admitted it.
- 11. Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out.
- 12. Having had a spiritual awakening as the result of these Steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.
